A MOTION WAS MADE BY STEVE RUPPERT AND SECONDED BY ROBERT KERCHER THAT THE FEBRUARY O & M BILLS BE APPROVED FOR PAYMENT AND CHECKS BE ISSUED. MOTION PASSED UNANIMOUSLY.

OLD BUSINESS

WORK REPORT: O&M worked a few leaks, replaced a fitting at the pumphouse. Issue with discharge meter – replaced. Boring rig is back and working.

USDA Rural Development loan – A bond attorney will be required to oversee the bonds for the loan. Rammelkamp found one to bid it. Gilmore & Bell out of St. Louis has an estimated cost of \$25,000.

Illinois Alluvial Regional Water Company update -65% of easements are done. Phase I is excepted to go out for bid in April. Water samples were tested.

NEW BUSINESS
